Cost-of-Living and Economic Pressure ~30-35%

- Many respondents pointed to the high cost of living in New York City—as seen in repeated phrases including 'too expensive,' 'cost of living is too high,' 'rent is very high,' and 'can't afford kids.'
- They describe economic conditions that make it hard to stretch incomes (or raise children) comfortably in the city.

Safety, Crime, and Urban Disorder ~25-30%

- A second major theme was concern over public safety. Respondents mentioned 'not safe,' 'dangerous,' 'crime is up,' and similar warnings about the urban environment.
- These comments suggest that many feel that for children, NYC's neighborhoods (or even its public transport) are risky places to live.

Family Status and Life-Stage Considerations ~25-30%

- For some younger respondents, being 'too young,' 'not married,' or 'not ready yet' is a reason not to rule out a move elsewhere and tie themselves to an environment they see as potentially unsuitable for raising a family.
- Preconceptions about the family lifecycle figure prominently as a reason not to 'stay' for the kids' sake when other options are available.

Other Related and Miscellaneous Reasons ~5-10%

- A few responses focus on quality-of-life issues (desiring more space, better schools, a quieter or safer environment) or simply state a personal preference to be somewhere else.
- There are also a number of brief or non-substantive answers ('ok', 'idk', or even frustrated 'none of your business') that fall into this catch-all group.

Economic/Affordability Concerns ~55-60%

- Many respondents mention that everything—from rent and housing to basic necessities—is 'too expensive' or 'costs are out of control.'
- Terms and phrases such as 'cost of living,' 'expensive,' 'high rent,' 'inflation,' and 'money' occur very frequently.
- This bucket captures the overwhelming sense that New York City has become financially unsustainable.

Safety and Crime Issues ~40-45%

- A large share of answers refer to feeling 'unsafe,' citing increasing crime, violence on the streets or subways, and a general deterioration in public security.
- Words like 'crime,' 'unsafe,' 'dangerous,' and 'violence' appear often, often paired with other concerns about quality of life.

Quality of Life, Overcrowding, and Urban Stress ~25-30%

- Respondents talk about the 'overcrowding,' 'stress,' 'noise,' 'dirtiness' and a sense that the city's overall environment—its pace and disorder—has become unbearable.
- Comments such as 'too much stress,' 'too busy,' 'dirty,' 'ghetto,' or 'no way to get away from the concrete' show that urban density and declining neighborhood conditions are a concern.

Political, Cultural, and Ideological Grievances ~10-15%

- A subset complain about local politics and the ideological direction of the city, sometimes citing dissatisfaction with governance or political 'partisanship.'
- Examples include direct references to political parties, 'liberal' or 'Democrat' policies, or the notion that authorities are 'corrupt' or not supportive of mainstream preferences.

Family, Weather, and Desire for Change $\sim 10-15\%$

- Other responses mention more 'personal' reasons wanting a different pace or environment, a preference for warmer climates (Florida, Texas, etc.), or the desire to be closer to family.
- Although less frequent than cost or safety concerns, these reasons underscore how lifestyle and personal well-being factor into the desire to leave.

Financial Constraints and Affordability ~45-50%

- Many respondents mentioned they 'couldn't afford to move,' cited the 'cost of moving,' 'no money,' 'lack of funds' or 'high cost of living.'
- Many people stayed because leaving would have meant a major financial hurdle—with either moving expenses or the risk of not being able to support themselves elsewhere.

Family, Roots, and Social Ties ~30%

- A large number of respondents said things like 'born and raised' or 'it's home.'
 'Family' was named over and over.
- Respondents talked about having kids in school, being close to parents or grandchildren, and maintaining long-standing personal and community networks.

Employment and Career Considerations ~15-20%

- Many reasons were tied to work or career: respondents noted that 'my career network,' 'job opportunities' and 'better-paying jobs' in New York City were significant pull factors.
- In a competitive job market, staying put was seen as a safe bet for professional stability.

Love of the City, Culture, and Amenities ~10-15%

- A vibrant urban lifestyle appeared repeatedly as a reason to stay. People said they 'love the city,' mentioned its 'endless entertainment options,' 'diverse culture,' and the energy and convenience that define New York City.
- For these respondents, the city's cultural and social fabric makes it the only place they can see themselves having the lifestyle they want.

Other Factors ~5% or less

- A few responses noted timing, inertia ('I haven't decided yet'), health or educational reasons and, on occasion, even political or environmental preferences.
- Some brief or non-standard responses fell into miscellaneous or unclear categories, but these were a relatively minor share.
